THENCE NORTH 89°01'09" EAST, A DISTANCE OF 74.00 FEET;

THENCE SOUTH 00°58'51" EAST, A DISTANCE OF 296.00 FEET;

THENCE SOUTH 89°01'09" WEST, A DISTANCE OF 74.00 FEET;

THENCE NORTH 00°58'51" WEST, A DISTANCE OF 296.00 FEET TO THE **POINT OF BEGINNING**.

CONTAINING AN AREA OF 0.503 ACRES, (21,904 SQUARE FEET), MORE OR LESS.

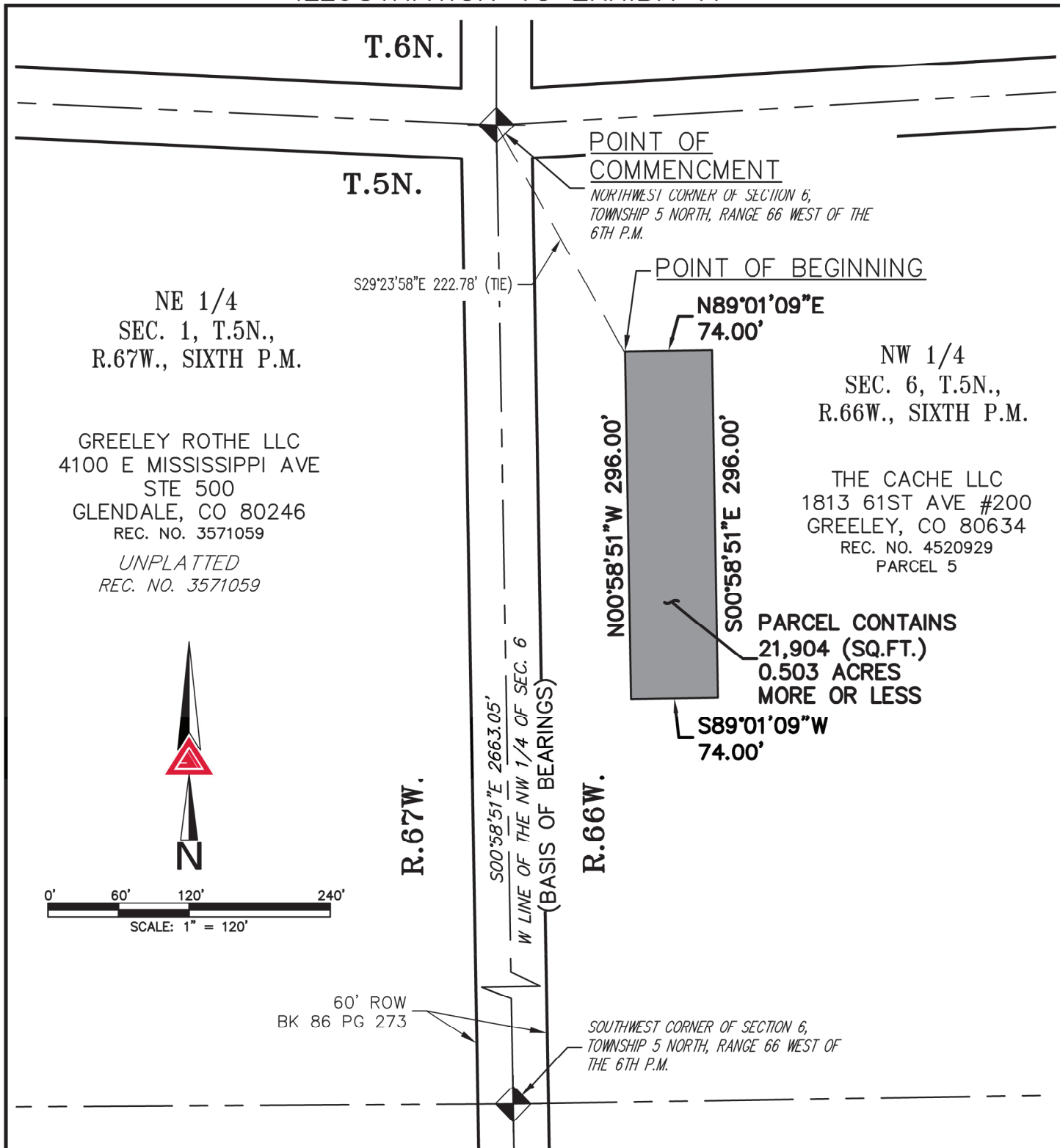

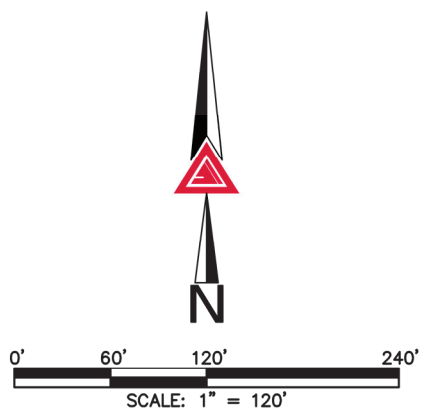
