A PARCEL OF LAND BEING A PORTION OF PARCEL 5 AS DESCRIBED IN A QUIT-CLAIM DEED RECORDED AT RECEPTION NO. 4520929 IN THE OFFICIAL RECORDS OF THE WELD COUNTY, COLORADO, CLERK AND RECORDER'S OFFICE, SITUATED IN THE NORTHWEST QUARTER OF SECTION 6, TOWNSHIP 5 NORTH, RANGE 66 WEST OF THE SIXTH PRINCIPAL MERIDIAN, SAID COUNTY AND STATE, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS.

COMMENCING AT THE NORTHWEST CORNER OF SAID SECTION 6, WHENCE THE WEST LINE OF SAID NORTHWEST QUARTER BEARS SOUTH 00°58'51" EAST, A DISTANCE OF 2663.05 FEET, ALL BEARINGS HEREIN ARE REFERENCED THERETO.

THENCE SOUTH 17°32'21" EAST, A DISTANCE OF 630.87 FEET TO THE **POINT OF BEGINNING**;

THENCE NORTH 89°01'09" EAST, A DISTANCE OF 148.00 FEET;

THENCE SOUTH 00°58'51" EAST, A DISTANCE OF 53.04 FEET;

THENCE SOUTH 36°56'48" WEST, A DISTANCE OF 240.78 FEET;

THENCE NORTH 00°58'51" WEST, A DISTANCE OF 242.96 FEET TO THE **POINT OF BEGINNING**.

CONTAINING AN AREA OF 0.503 ACRES, (21,904 SQUARE FEET), MORE OR LESS.

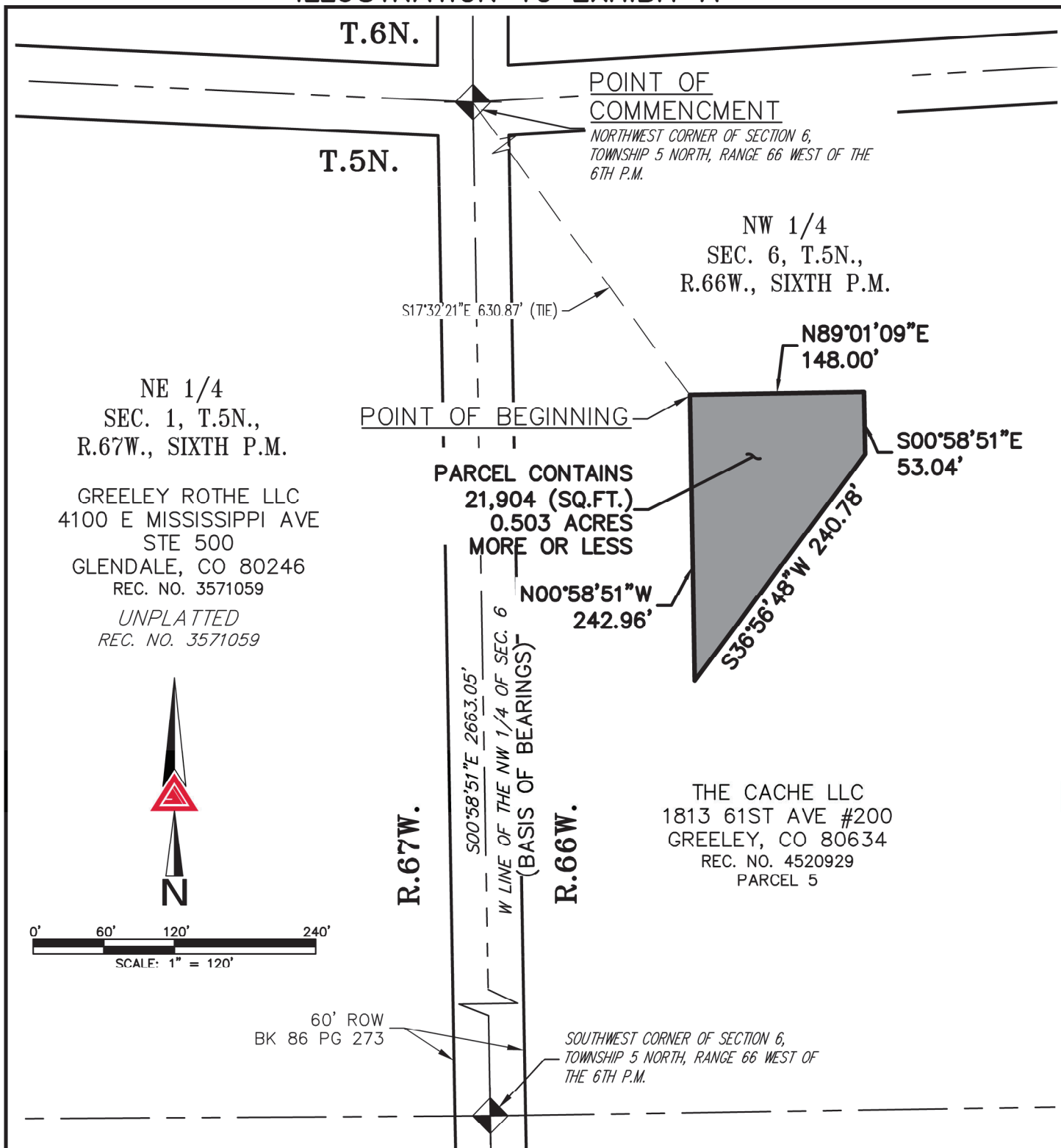

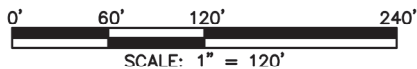
